Symptoms caused by exposure

Inhalation:	May cause irritation to respiratory system. Breathing in high concentrations can produce central nervous system depression which can lead to loss of coordination, impaired judgement and if exposure is prolonged, unconsciousness.
Skin:	Irritant. May include redness and dryness.
Eye:	Mild irritant. May include redness and soreness.
Ingestion:	Large amounts may cause nausea and vomiting.

SECTION 5 FIRE FIGHTING MEASURES

Suitable extinguishing equipment

Use water fog or spray, foam, dry agent.

Specific hazards arising from the chemical

May form flammable vapour mixture with air. Avoid all ignition sources. Flameproof equipment necessary in area where chemical is being used. Nearby equipment must be earthed. Vapours may travel considerable distances to source of ignition and flashback. Vapours may accumulate in low or confined areas. Combustion products may include carbon monoxide and/or carbon dioxide.

SECTION 6 ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

Avoid contact with spilled or released material. Avoid breathing in vapours. Shut off leaks, if possible without personal risks. Isolate hazard area and deny entry to unnecessary or unprotected personnel. Ventilate contaminated area thoroughly. Remove all sources of ignition in the surrounding area.

Environmental precautions

Use appropriate containment to avoid environmental contamination.

Methods and materials for containment and cleaning up

Absorb with dry earth, sand or other non-combustible and inert material. Collect and seal in properly labelled containers or drums for disposal. Wash down area with excess water.

Precautions for safe handling

Flammable product. Avoid breathing vapours. Avoid skin and eye contact. Handle and open containers with care in a well-ventilated area. Ensure that the workplace is ventilated such that the Occupational Exposure limit is not exceeded. Wash thoroughly after handling. Do not eat, drink or smoke in contaminated areas. Electrostatic charges may be generated during transfer. Electrostatic discharge may cause fire. Ensure electrical continuity by earthing all equipment. Do not empty into drains.
